## **Ethics statements**

The journal Geographia Technica subscribes to the principles of the <u>Committee on</u> <u>Publication Ethics (COPE)</u>, of the <u>EASE Toolkit for Authors</u>: <u>EASE</u> and of the Budapest Open Access Initiative <u>https://www.budapestopenaccessinitiative.org/</u>.

Thus, among other responsibilities, editor-in-chief and guest editors must ensure that all manuscripts received in their journal are reviewed for their scientific content, regardless of gender, race, religion, citizenship, ethnic origin or political philosophy of the author(s). In addition, editor-in-chief and guest editors must respect the intellectual independence of authors and ensure that any information relating to manuscripts submitted by authors is kept confidential. Editorial responsibility for any manuscript authored by an editor must be delegated to some other qualified person of the Editorial Board of the journal Geographia Technica.

In order to avoid ethical violations, the journal Geographia Technica requires all authors of a manuscript to sign, even before the start of the review process, a Letter of Agreement, which requires the following:

- originality of the research
- the obligation for all the authors listed in a scientific paper to have significant contributions regarding the elaboration of the study, but also vice versa, i.e. no person who contributed to the article should not be missing from the list of authors
- avoiding the manipulation of citations, which means that citations that do not contribute to the scientific content of the research and that aim to increase the citations of a certain author or journal are interpreted as scientific malpractice avoiding plagiarism

The secretariat of the journal Geographia Technica will carry out a check regarding the plagiarism and if the similarity report invalidates the originality of the manuscript, we will definitively reject any future contribution of the respective authors.

We recommend to the authors that before submitting to the journal Geographia Technica to do the anti-plagiarism test and we suggest some of the possible programs:

## **Peer Review Policy**

The papers submitted for publication to the Editor undergo an anonymous peer review process, necessary for assessing the quality of scientific information, the relevance to the technical geography field and the publishing requirements of our journal. The contents are reviewed by two members of the Editorial Board or other reviewers on a double-blind review system. Reviewers should not consider manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or institutions connected to the papers.

Reviewers should evaluate manuscripts objectively and express their views clearly and with plausible arguments. Reviewers must treat any information in the manuscripts

analysed discreetly. The peer review process respects the originality and personal opinions of the authors, but reserves the editor's right to demand changes, based on reviewers' comments in order to preserve high scientific quality and our readers' interest.

Reviewers are required to report irrelevant citations. But at the same time, the reviewers should include in the recommendations and provide to authors any concerns regarding omitted citations. The reviewer's comments for the improvement of the paper will be sent to the corresponding author by the editor. After a preliminary decision resulting in the request to perform a minor or major revision, making a resubmission is a natural thing. When resubmitting, the authors do not submit the manuscript as a new submission, but rather use the original manuscript id number and click the 'Resubmit' button next to the manuscript. The reviewers will check if the manuscript meets the qualitative English language criteria, and the authors will perform the necessary for a final English proofreading process.

After the author changes the paper according to the reviewers' comments, the article is published in the next number of the journal.

## **Publication policy**

The journal Geographia Technica undertakes that the time between submission and publication, initially in online first category, should be as short as possible, but without neglecting the principles of quality peer review. Online first publication and of course volume publication will only be possible if the authors have paid for the article processing charge. All authors should disclose in their manuscript any financial or other substantive conflict of interest that might be construed to influence the results or interpretation of their manuscript. All sources of financial support for the project should be disclosed.

The editor-in-chief has complete responsibility and authority to accept or reject a submitted manuscript. Based on an initial screening process the editor-in-chief decides whether the manuscript is suitable for review or not. Desk-reject is done for papers that fail to meet the submission requirements, and which hence cannot be accepted.

As soon as the manuscript has received the acceptance decision, it will be published "online first" including DOI on the website of the journal Geographia Technica. At the end of March or October, accepted manuscripts are assigned to regular issues. Additional yearly special issue may be published.

Eventual paper rejections will have solid arguments, but sending the paper only to receive the comments of the reviewers and then request a withdrawal, is strongly discouraged.

## **Open Access Policy**

By "open access" to [peer-reviewed research literature], we mean its free availability on the public internet, permitting any users to read, download, copy, distribute, print, search, or link to the full texts of these articles, crawl them for indexing, pass them as data to software, or use them for any other lawful purpose, without financial, legal, or technical barriers other than those inseparable from gaining access to the internet itself. The only constraint on reproduction and distribution, and the only role for copyright in this domain, should be to give authors control over the integrity of their work and the right to be properly acknowledged and cited.

The journal Geographia Technica operates under the <u>Creative Commons – Attribution-NonCommercial-NoDerivatives 4.0 International – CC BY-NC-ND 4.0</u>. This allows for the reproduction of articles, free of charge, for non-commercial use only and with the appropriate citation information. Authors retain the copyright of their article but agree to assign to the journal Geographia Technica the right to reproduce it in all forms and media under the "CC BY-NC-ND 4.0" license.

The published articles and volumes are archived on the website of the journal Geographia Technica <u>http://technicalgeography.org/index.php/journal-archive</u> and from here they can be downloaded and used freely, of course, specifying the authors and coordinates of the article.

Authors can archive only the publisher's PDF version in an open access repository (e.g. institutional repositories, on the funder's designated repository at the funder's request or as a result of a legal obligation, on the authors' own website).

All authors publishing in Geographia Technica accepts these as the terms of ethics statements for publication and open access policy.
